**HORSE TRAIL RULES**

**It shall be unlawful within the Sand Creek Conservation Area for any person:**

1. To treat a horse cruelly or knowingly permit such treatment.
2. To ride or lead a horse that is vicious, unmanageable or physically unfit for riding.
3. To ride a horse in such a manner as to injure or endanger the person or property of the Conservation District.
4. To ride a horse that is not adequately and safely equipped for riding.
5. To race horses. Horses must always be kept under control and ridden at permitted gaits: walk, trot or slow canter.

**Rider shall**

1. Stay on established trails.
2. Slow to a walk on meeting other riders or hikers.

*I, consideration of permission granted to me by the District to ride a horse on the trails of the District recognizing and acknowledging that there are risks of physical injury to me and others, I voluntarily assume such risks and hereby release, discharge and hold harmless the District, its trustees, officers, agents, servants employees and volunteers from any and all claims, losses, damages or expenses which I or any person riding a horse on my permit may incur by reason of damage to my or their persons or property as well as all claims of third parties incurred by reason of damage to their person or property resulting from such equestrian activity.*
