5. Staff Reports:

Richie Wolf gave a brief update reporting that IPARKs was sending a check for approximately \$6500.00 for COVID -19 relief. The American Bloom was canceled. A letter was received from Bill Faber recommending that the riding trails be closed during this pandemic due to social distancing. Richie Wolf responded to his request stating that all Conservation areas will remain open as permitted by the Governor's current order. Trustee Bendsen agreed that it was a great decision to keep the areas open for the public and likes seeing tax payers enjoying the areas.

6. Other:

Richie Wolf discussed the opening of the Friends Creek Campground as of May 1st, when the current Governor's executive order ends. Richie said that the washroom would not be open for public use as most campers have their own facilities and the campground has water and a dump station. After some discussion, the Board recommended that Richie follow the governor's orders and check with the District's attorney and the Governor's office if the executive order is not lifted May 1st before opening the campground. Richie also brought to their attention that Summer Camp begins June 1st and he will wait until the Governor makes an announcement whether to extend the executive order nor not before making a decision whether to cancel the camp or to hold it.

COMMENTS FROM TRUSTEES:

Trustee White reported that a patron had complained to him about the number of groups walking the bike trail and being disrespectful to bicyclists by not moving over and using profanities when they passed by them. Richie Wolf suggested that the best advice to give is for patrons to call the Sheriff's office.

Trustee White also asked if there was any update on the FOIA request and Richie reported that there had been no more news and the 60 day time period to appeal had passed.
